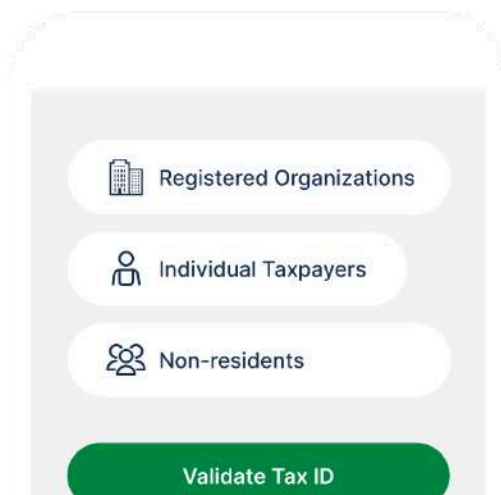

A Tax Identification Number (Tax ID) is a unique number jointly issued by the Nigeria Revenue Service (NRS) and the Joint Revenue Board (JRB) in accordance with Nigerian tax laws for the purpose of identifying individuals and entities for tax administration, compliance, and enforcement.

Under Nigeria's tax administration framework, a Tax ID is not created in isolation.

A valid Tax ID is mandatory for accessing many public and private services, including banking, employment documentation, government contracts, and statutory filings.

**Companies and business entities** registered with the CAC. Organizations, trustees, and partnerships conducting regulated or taxable operations



**Non-residents** with tax obligations or  
economic presence in Nigeria
